A Supplier may be considered to have a conflict of interest with one or more parties in this bidding process if they have a relationship with each other, directly or through common third parties that puts them in a position to have access to information about or influence on the bid of another Supplier, or influence the decisions of Abaad regarding the bidding process.

Suppliers processing personal data on an Abaad contract will be required to sign a data processing / sharing agreement as part of the contract. Refusal to sign such an agreement constitutes refusal of the contract terms and forfeiture of the contract on the part of the supplier.

Anti-money laundering, anti-bribery, anti-corruption and anti-terrorism legislation and donor regulations require Abaad to screen suppliers against various international lists to ensure due diligence. Submission of the quotation constitutes acceptance of these screening practices.

All prices shall be quoted by the Bidder in USD, unless otherwise stated. Similarly, all payments will be made in USD.
